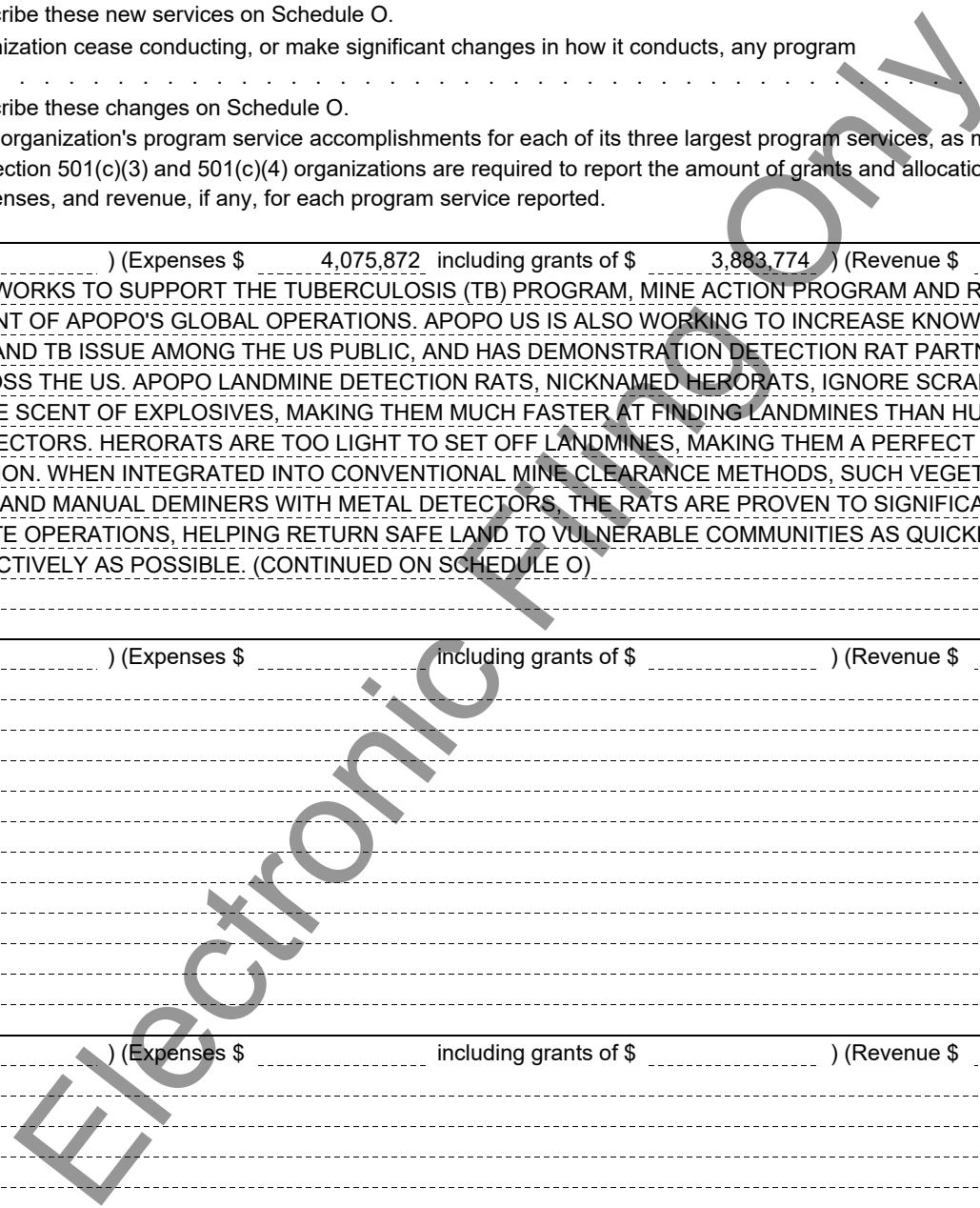

APOPO US IS ALSO WORKING TO INCREASE KNOWLEDGE OF THE LANDMINE AND TB ISSUE AMONG THE US PUBLIC, AND HAS DEMONSTRATION DETECTION RAT PARTNERSHIPS WITH ZOOS ACROSS THE US. APOPO LANDMINE DETECTION RATS, NICKNAMED HERORATS, IGNORE SCRAP METAL AND ONLY DETECT THE SCENT OF EXPLOSIVES, MAKING THEM MUCH FASTER AT FINDING LANDMINES THAN HUMANS WITH METAL DETECTORS. HERORATS ARE TOO LIGHT TO SET OFF LANDMINES, MAKING THEM A PERFECT TOOL TO SPEED UP DETECTION.
